- All the customers are requested to check the driver and truck details before loading the goods.
- User are supposed to give the payment which is appeared on application and not the one asked by driver. If driver demands more money user is subjected to contact ShipBerg. ShipBerg work towards betterment of user and remains for it.
- As per goods transportation law Insurance of Goods is to be taken care only by the customer. ShipBerg is not responsible incase of goods damage / accident/Theft/Robbery. ShipBerg will assist you through all legal related issues and necessary documents.
- ShipBerg doesn't give assurance for the goods safety, as safety of goods rely completely between both customer and driver/truck operators.
- We will verify transporters to the best of our knowledge before signing attachment, but we don't give 100% assurance for the goods safety, since ShipBerg is just a booking portal and incase of goods theft /damage transporter is responsible.
